The publication of manuscripts in the scientific journal **News of the National Academy of Sciences of the Republic of Kazakhstan. Series of chemistry and technology** is performed using the Open Journal System, online submission and review system. registration or authorization is available in the "Submission of materials" section.

The author of the correspondence is marked with an asterisk*

THE REQUIREMENT FOR THE DESIGN OF THE ARTICLE

Articles are accepted in Kazakh, Russian or English only through the website <https://journals.nauka-nanrk.kz/>.

One author can submit only one article in one issue! The number of authors should not exceed 5 people. The authors' references to their works should not exceed 20% of the literature used.

The Editorial Board accepts previously unpublished articles in the scientific areas of the journal. Font size-12, literature-9, table text-9, font-Times New Roman, alignment - to the width of the text, spacing-single, paragraph indent-1 cm, margins: top and bottom – 2 cm, left and right – 2 cm. Figures, tables, graphs, diagrams, etc. are presented directly in the text, indicating the numbering and title (for example, Figure 1 – The name of the figure). The number of figures, tables, graphs and diagrams should not exceed 20% of the total volume of the article (in some cases up to 30%).

The volume of the article (excluding the title, information about the authors, annotation, keywords, bibliography) should be at least 2000-3500 words. The authors must indicate in the cover letter in the Open Journal System that the submitted article/manuscript has not been published anywhere before, and that the article does not contain borrowed text fragments from other works without references to them.

Article structure:

First page:

The first line-specifies the ORCID ID, UDC, and NTAMR index (MRNTI).

The title of the article (Title) should reflect the essence and content of the article and attract the reader's attention. The name should be short, informative, and free of jargon or abbreviations. The optimal length of the title is 5-7 words. The title of the article should be presented in Russian, Kazakh and English. The title of the article is represented in bold, lowercase letters, and the alignment is centered. The author (s) of the article – Initials and surname, place of work (organization), city, country, phone number, email – in Russian, Kazakh and English. Information about the authors is presented in the usual font in lowercase letters, alignment-in the center.

The structure of the abstract includes the following MANDATORY items: An introduction to the topic of the study. The purpose, main directions and ideas of scientific research. A brief description of the scientific and practical significance of the work. Brief description of the research methodology. The main results and analysis, conclusions of the

research work. The value of the research (the contribution of this work to the relevant field of knowledge). Practical significance of the results of the work. Keywords/phrases - 3-5 words in Russian, Kazakh and English. Abstract – at least 200-300 words, keywords-5-10 words, the volume of the main text – 4-6 pages (2000-3500 words). At the end of all journals, the list of references should be presented in square brackets (REFERENCES) in English, not exceeding 1 page (typed in 9 pins). And the list of references should contain transliteration (transliteration - <http://www.translit.ru>).

If the article is in Kazakh and Russian, then you must additionally specify the literature in English. Citation (self-citation) of the article by the author is allowed for 20%.

At the end of the article, a page with the signature of all the authors should be attached.

All pages of the article, as well as tables, lists of references, inscriptions under figures and figures should be numbered.

ARTICLE ACCEPTANCE ALGORITHM:

1. Article accepted on the website StrikePlagiarism.com. the site is checked for plagiarism. In case of exceeding the plagiarism index by more than 20%, the authors lose the right to publish in the journals of the National Academy of Sciences of the Republic of Kazakhstan.

2. An article that has passed anti-plagiarism is sent to anonymous reviewers. Secret reviewers review the article from 2 weeks to 1 month.

3. As a result of expert opinions, the editorial board makes a decision on the transfer of the article for publication, on the need for correction or refusal. If necessary, according to the comments of reviewers and editors, the article is sent to the authors for corrections and additions.

4. The article, revised by the authors, is subject to return to the editorial office within a month. Articles that do not meet the requirements of the journal are not accepted

The authors are responsible for the reliability and significance of the scientific data, as well as for the scientific content of the work.

Sending an article to the editor means that the authors have not submitted the same materials (in the original, translation into another language or translation from another language) to another journal (s), have not been submitted for publication in another publication or in other journals. If, in the course of working on the article, it is established that similar material (possibly under a different name or in a different order of authors) is available.) if it was submitted to another journal, the article is returned immediately. Authors are also deprived of the right to publish articles in the journals of the National Academy of Sciences of the Republic of Kazakhstan.

DESIGN OF LITERATURE

References to books indicate the ISBN (10-or 13-digit). Abbreviate the names of only those magazines that are specified:

ARTICLE SUBMISSION DEADLINES

The journals of the National Academy of Sciences of the Republic of Kazakhstan are published 6 times a year, i.e. 1 time in 2 months.

By the 15th day of the issue date of the next issue of the journal (February, April, June, August, October and December), the journals are displayed on the website of the journals of the National Academy of Sciences of the Republic of Kazakhstan. Then, within 1 month, the printed edition of the magazine itself is published.

The deadline for submitting an article to the next issue of the journal is 1.5 months before the publication of the journal on the website (before January 1, before March 1, before May 1, before July 1, before September 1, before November 1).

The maximum term of the article under consideration, received by the editorial board – is up to 6 months.
